Block Parties for National Night Out

The best way to keep our subdivision safe is to know your neighbors. Block Parties will be in front of your Block Captain's house or the Park. **James Carter**, 779-0675, is the coordinator, who has contacted Bryan police to send reps to our parties. They will talk about burglaries and tips for preventing them. Westwood is made up of ten Blocks. Block Captains will be reimbursed for Block Party expenses up to \$10 plus \$2/Dwelling.

Five Blocks had a joint party at our community Park, with 35 people attending out of 114 dwellings. Deer Trail and Wilderness had a joint party, with 21 people out of 25 houses. Three held individual parities in front of their Block Captain's house. **Turtle Grove** had 11 people out of 13 houses, making theirs the highest rate of attendance. Total Block party attendance was 102 out of 184 dwellings. (107 attended in 2007, 127 in 2006 and 59 in 2005.)

Mark your calendars. This is the most important meeting we have each year. We need you or your proxy to attend this meeting. Our Community has five Board Members. Mark Coppock's term is up and another position is open, which has been vacant since June. Let us know if you are interested in running or who you would like to run by early January so you/they can be placed on the ballot. Anyone can be nominated at the meeting, but without proxies to back up that nomination, it is unlikely they will muster sufficient votes to win.

Shortly before the Meeting your Block Captain or a

Board Member will bring by a Proxy for you to sign. Even if you plan to attend, go ahead and sign the Proxy. Then, if you do attend the meeting, your Proxy will be returned to you. Quorum needed for meeting is 49 votes. At our last Annual Meeting (1/19/2009), 13 Members attended with 13 votes. Plus 64 Proxies equaled 77 votes. At that meeting, three new unopposed Board Members were elected.

In 2008, 17 attended with 16 votes plus 108 proxies.

In 2007, 11 attended with 15 votes plus 40 proxies.

Late Dues Billing System

Past due accounts to pay collection costs.

In the past, the extra cost that occured when attempting to collect late dues was paid for by all of us. Starting 1/31 of this year all extra cost caused by late due accounts will be charged directly to that account. The Board has implemented an automatoic late due billing system for those that are over one year late and will be charging them the cost of the extra "Past Due" bills that will be mailed to them. Our bookkeeper has been instructed to send an extra bill by regular mail to those who are over one year late as of 1/31 and add \$10 to the amount owed to cover cost. Our bookkeeper has also been instructed to send an extra bill by certified mail to those who are over one year late as of 9/30 and add \$30 to the amount owed to cover costs.

This billing system will run parallel to any other efforts the Board my implement to encourage late accounts to pay up. All other cost, like lawyer fees, filling liens, court cost, foreclosure cost, etc. will also be added to amount owed. The first Past Due bill has been mailed to the following and \$10 has been added to their bill.
